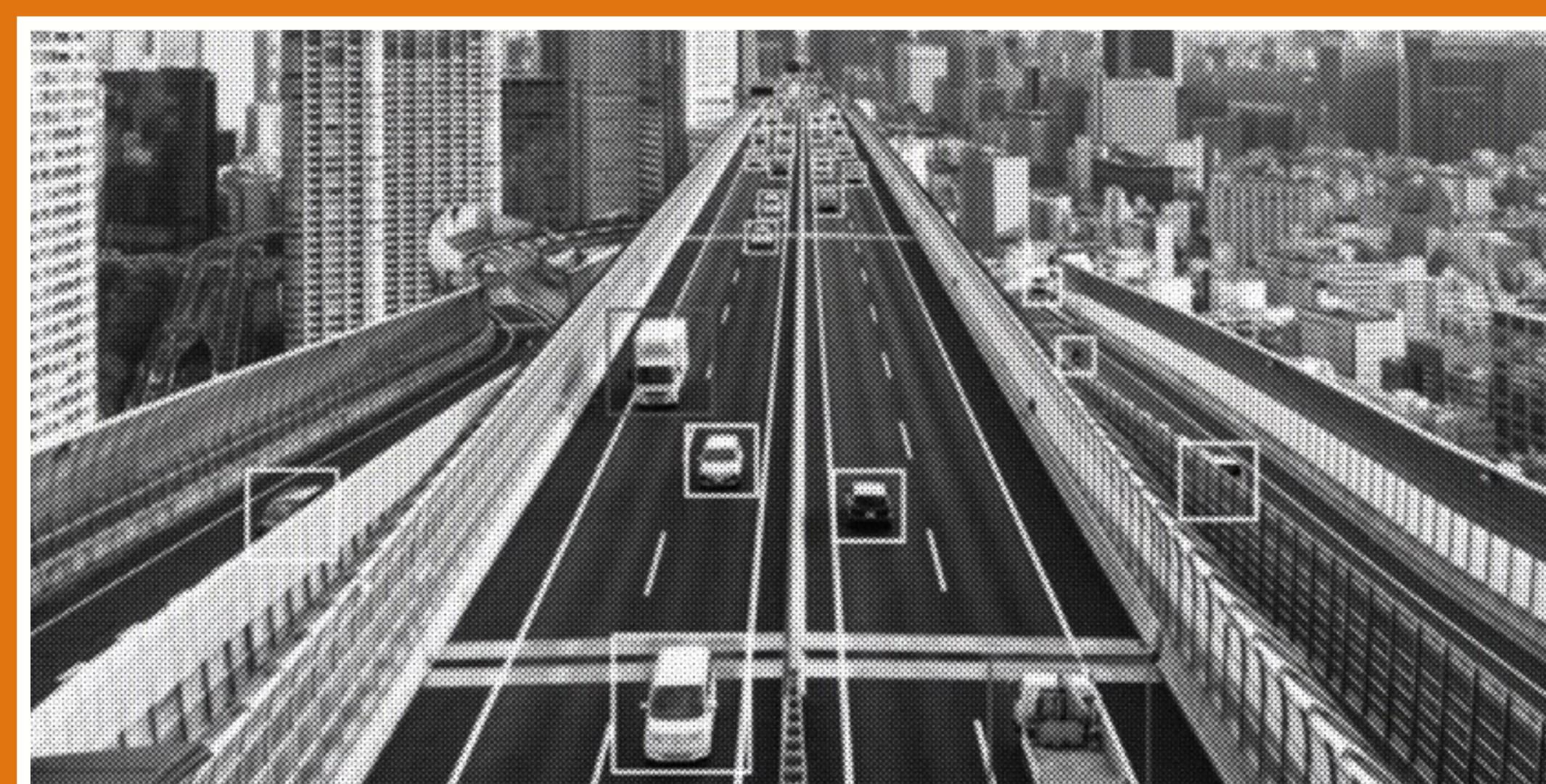

Mobility Data Interoperability Principles by Various Co-authors

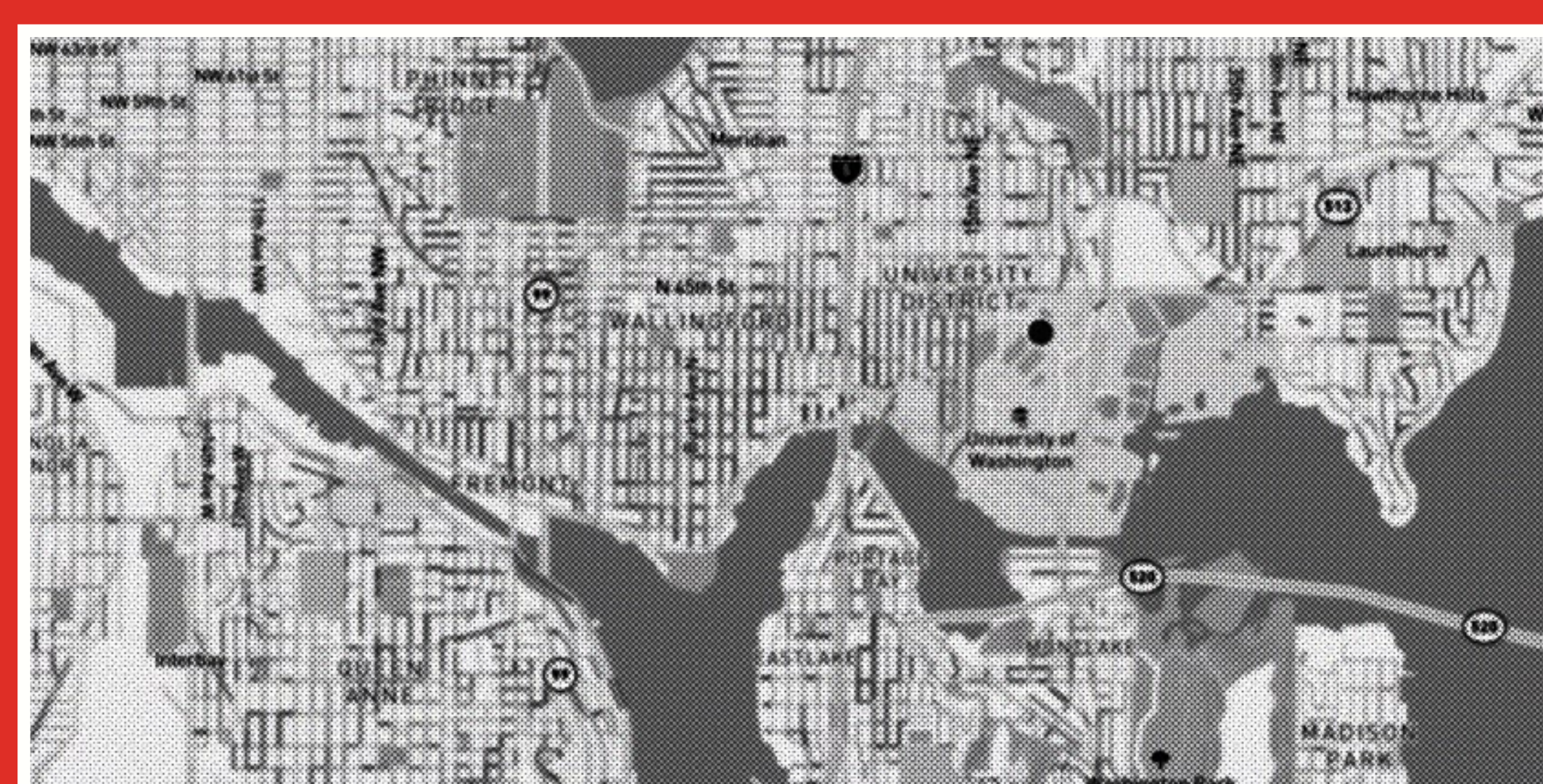
Encourage ongoing collaborations between various stakeholders, understanding that collective access requires mutual support.

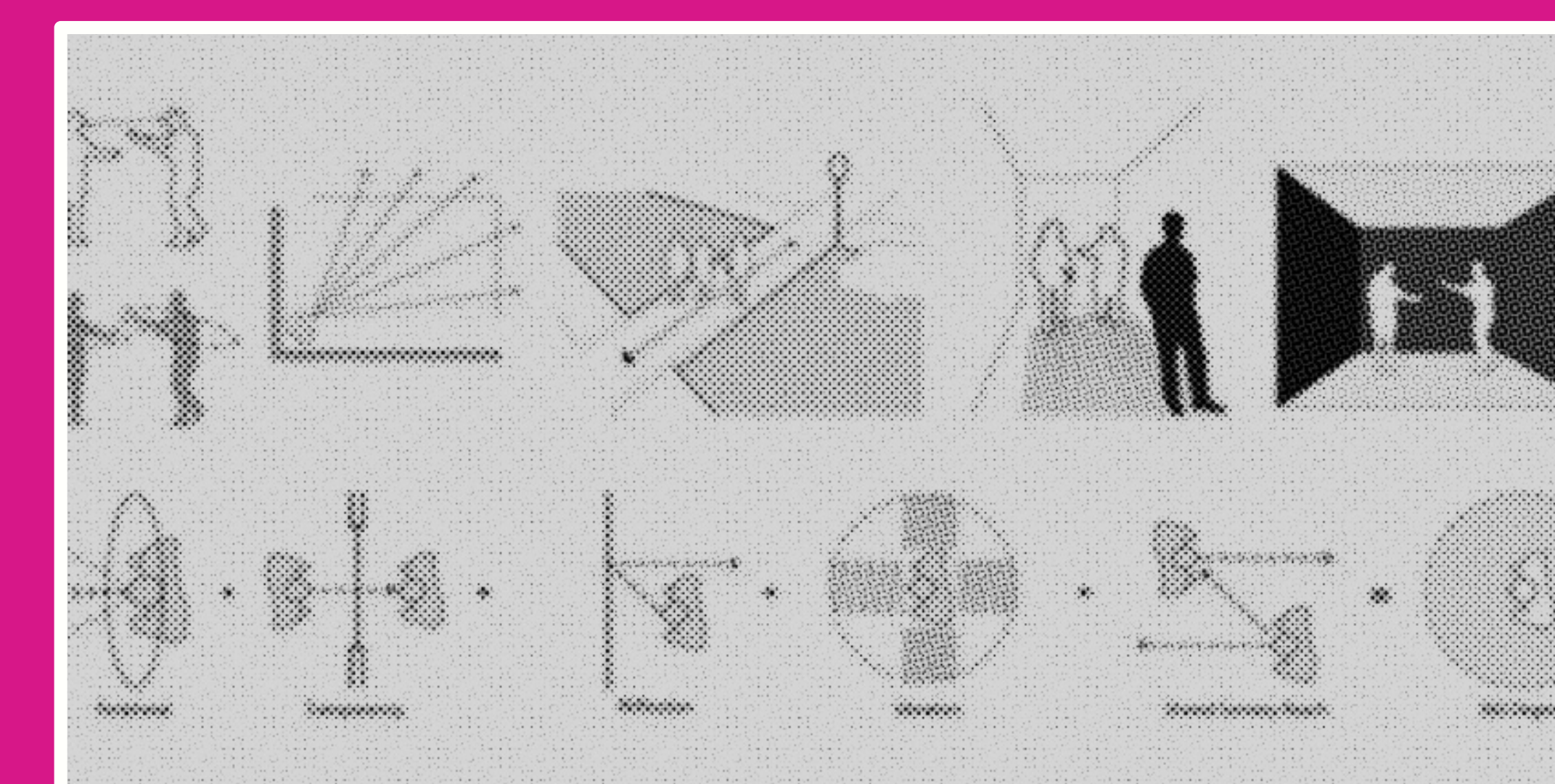
Promote collective access through open sharing of data, making it both available and interpretable to users.

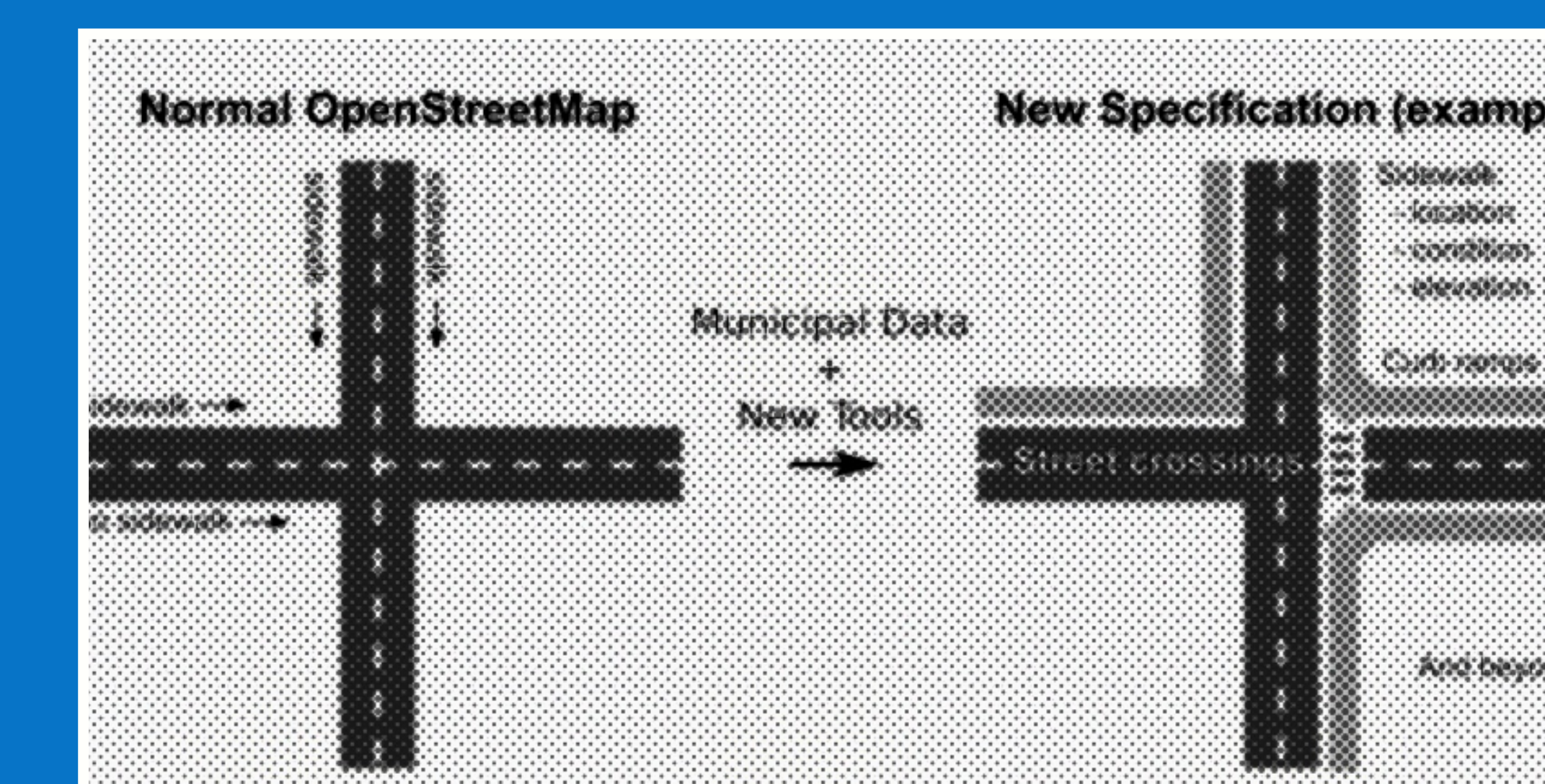
Center and uplift community members with lived experience when working on projects that cite accessibility and equity as values or goals.

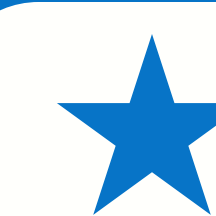
Sustainability

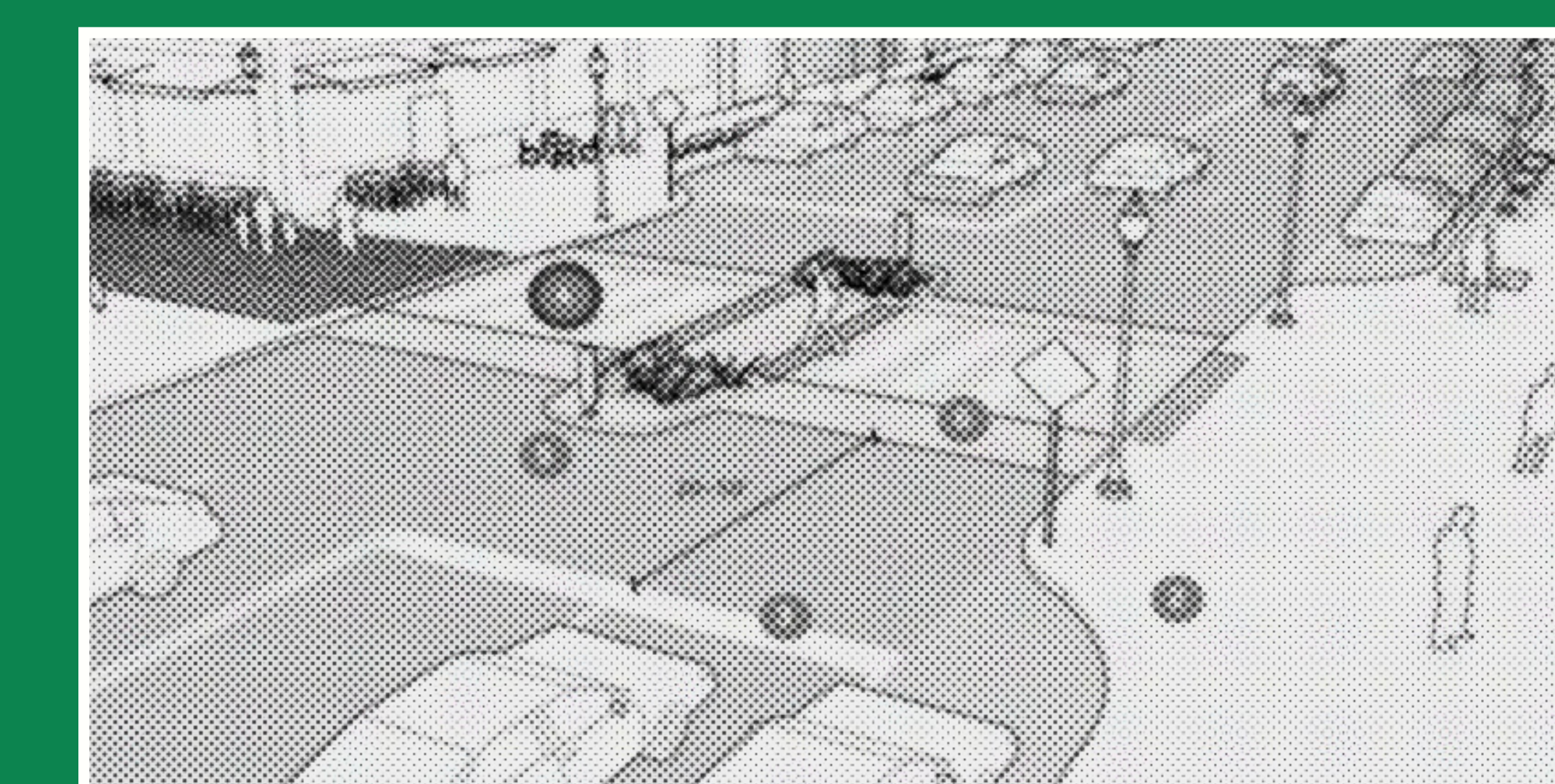
Understand that equity takes long, sustained efforts; imagine long term solutions that can adapt over time.

Shifting how social justice movements understand disability and contextualize ableism, disability justice lends itself to politics of alliance.



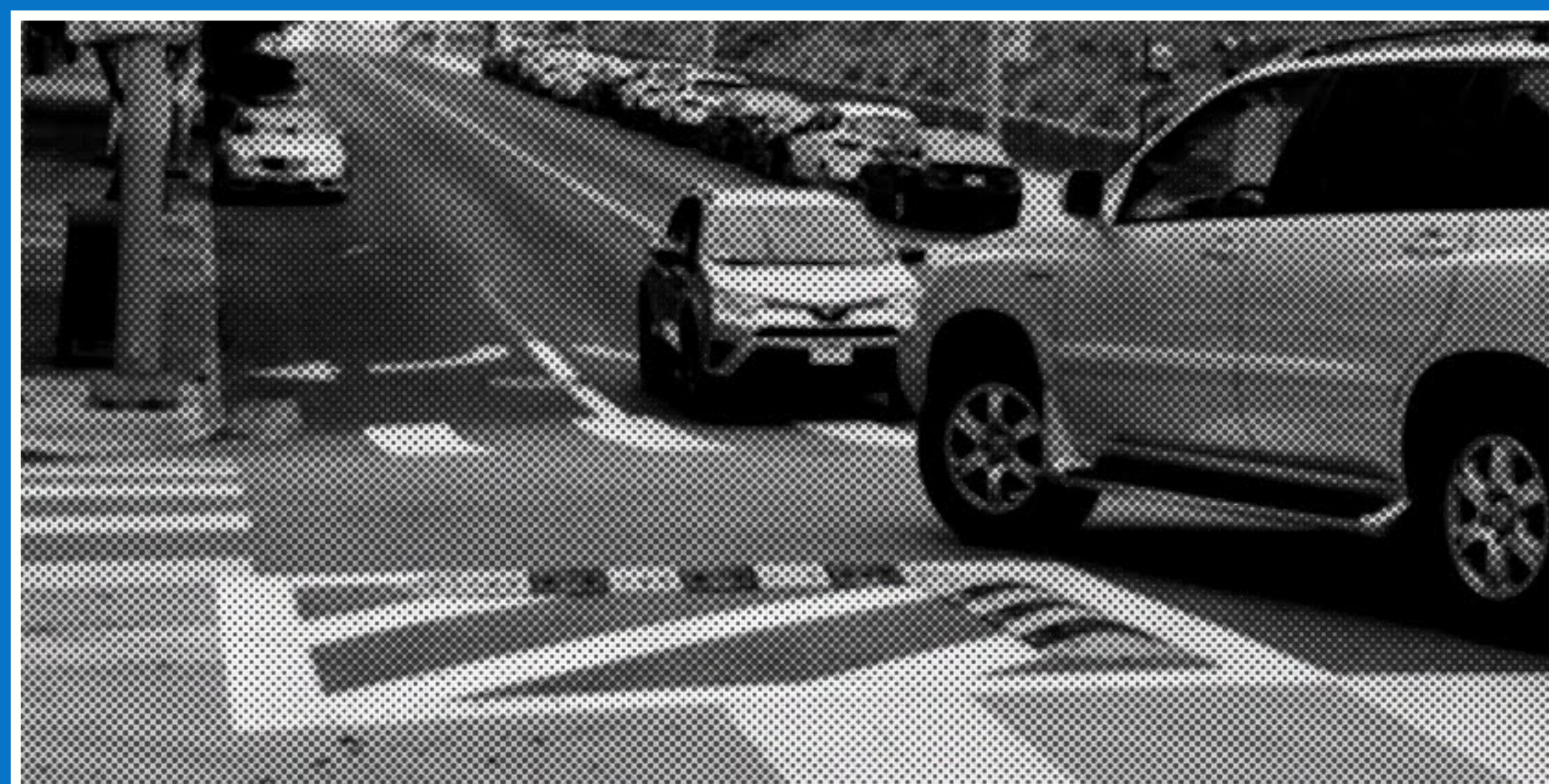

People have inherent worth outside of commodity relations and capitalist notions of productivity. Each person is full of history and life experience.



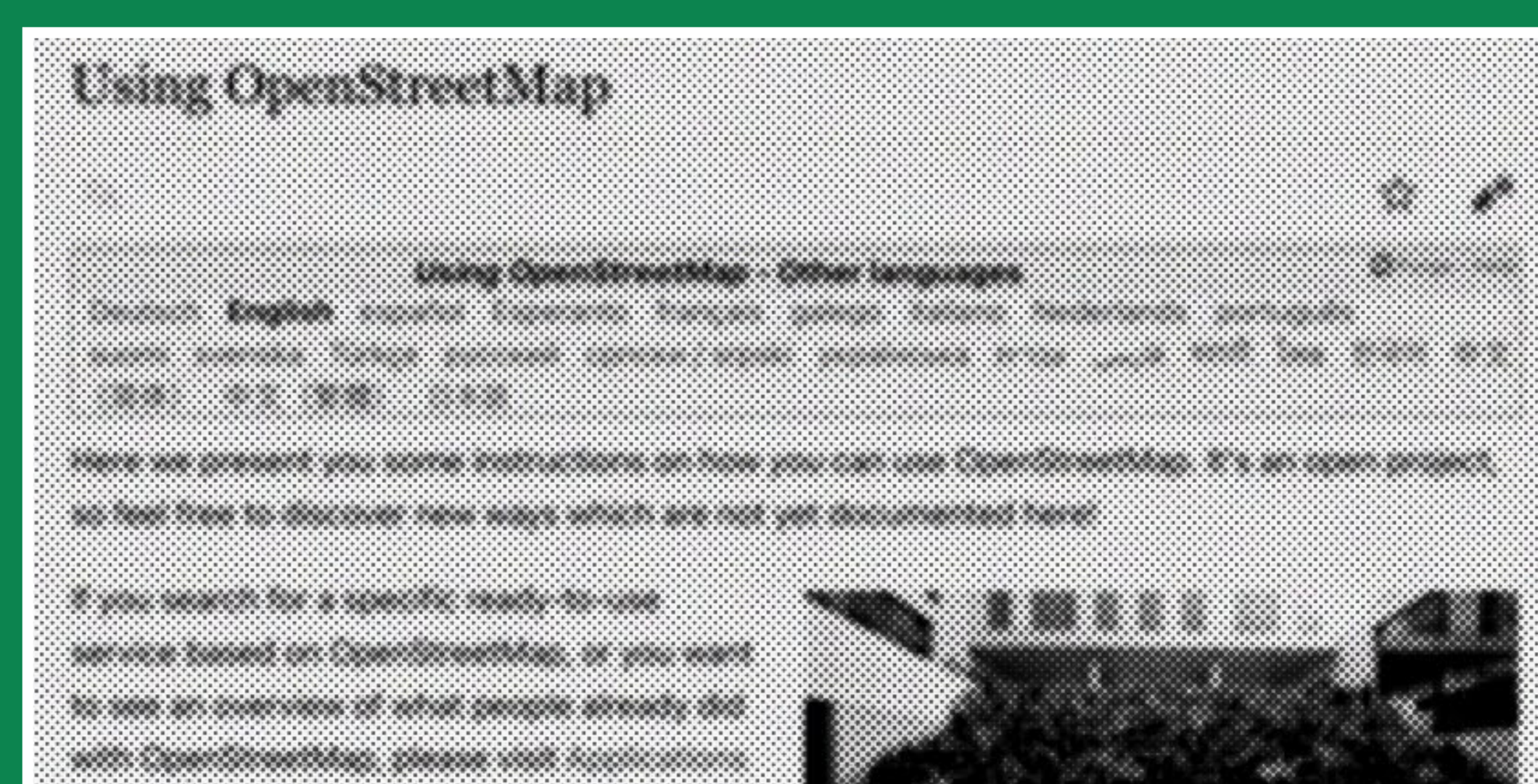

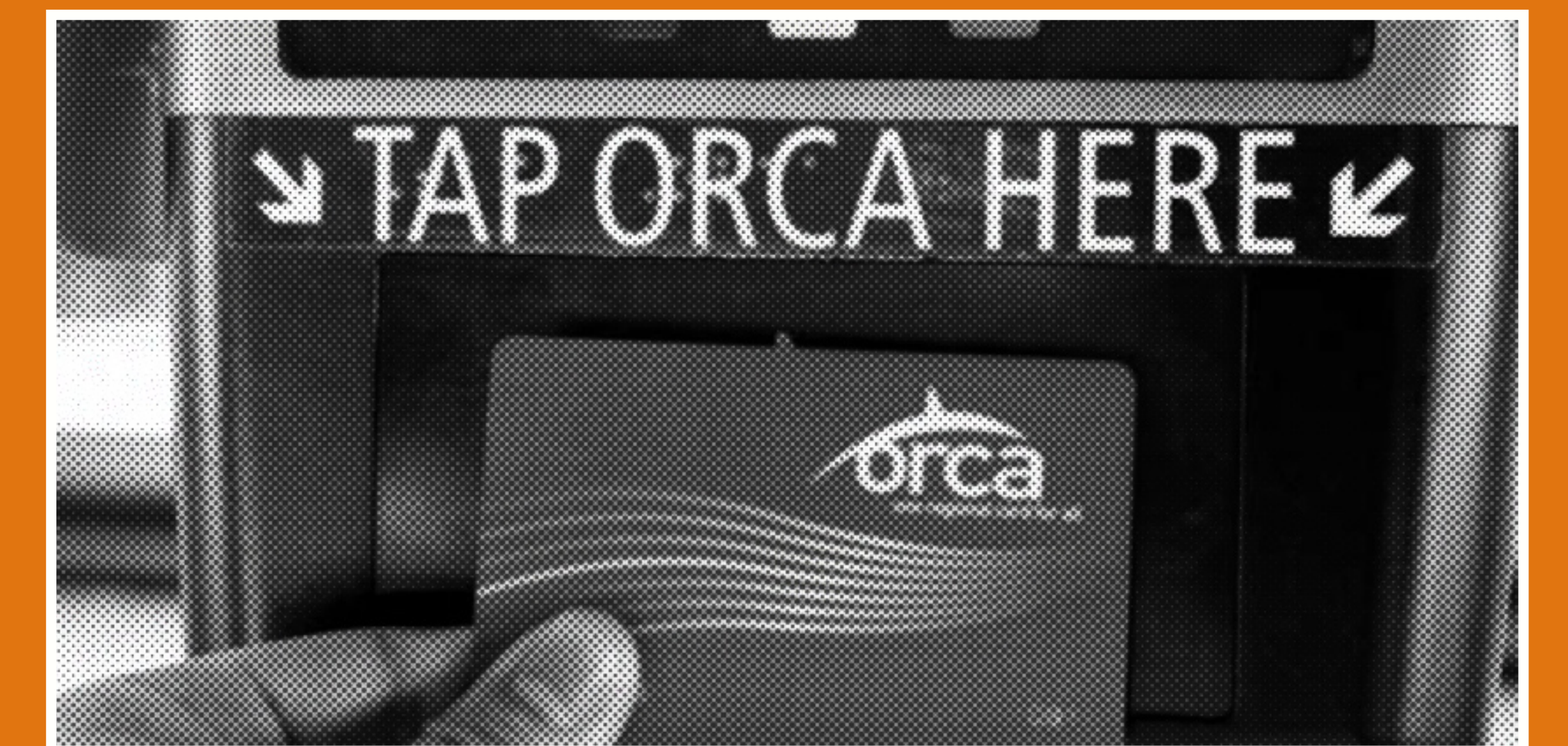
Disability Justice for Transportation Planners and Community Members

1. Choose an existing principle and imagine one, or several, scenarios where this principle applies to your own work
2. Talk amongst yourselves about the scenarios you came up with,
 - If someone chose the same principle as you, did you come up with the same or similar scenarios?
 - What actions in that scenario could you take to exemplify this principle, or disability justice, or mobility equity?
3. As a group(s), choose one principle of disability justice. Then, develop a set of 5+ questions that you may ask yourself when incorporating that principle into your work.
4. As a group(s), come up with a new principle entirely, expanding upon the existing principles. Be prepared to share a name and definition for your principle.
 - How does this new principle promote disability justice?
 - How does it differ/compare to other principles?
